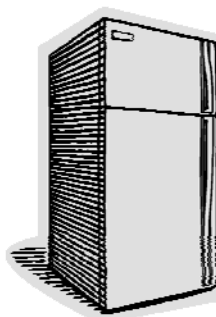

FREE Energy Services Available to Fuel Assistance Clients:

* Unless otherwise noted, the programs below are available to both homeowners and tenants who meet specific eligibility guidelines.



WEATHERIZATION: Funded by the **Department of Energy** and **National Grid**, the Weatherization Program is designed to keep your home warm in the winter and cool in the summer through weatherization measures such as insulation, weather-stripping, and air sealing. If you are a Fuel Assistance client and your place of residence has not been weatherized (insulation, weather-stripping, and air sealing) by Action since September 30, 1994, you may qualify for this program.



APPLIANCE MANAGEMENT PROGRAM: Funded by **National Grid**, this program can help you cut back on your electricity bill. If you are eligible, an Energy Auditor will review your electric usage, meter your refrigerator, provide energy-saving light bulbs, and inform you on how you can save on your bill. If your refrigerator uses too much energy, it may be replaced it for free. Water bed mattresses may also be replaced with regular mattresses. To qualify, you must be a National Grid electric customer and must have lived in your home for at least nine months. Ipswich residents are not eligible.

Homeowners Only →

HEATING SYSTEM PROGRAMS: We offer an emergency program to help homeowners repair or replace their heating systems. Depending upon available funding, we may also offer an annual heating system cleaning program.

UTILITY BILL DISCOUNTS: Fuel Assistance clients may also be eligible for a number of other utility bill discounts.

National Grid Gas:

- 20% discount
- Discounted rate of R-04 on residential heating bill
- Discounted rate of R-02 on non-heating (secondary use) bill

National Grid Electric:

- 33% discount
- Discounted rate of R-2 on electric bill

Verizon: Approximately \$9 discount on basic monthly phone bill

Oil Discount: Discount on oil usage up to allotted benefit amount

Note: In order to receive utility bill discounts, the Fuel Assistance client's name will need to match the name printed on the utility bill.
